

PHS Privacy Policy

1. Policy:

Portsmouth Hispanic Society recognises that your privacy is important to you and that you care about how your personal data is used and shared online. We respect the privacy of everyone who visits our website www.spanishportsmouth.org.uk (Our Site) or provides us otherwise with their personal data. In general we do not collect personal data about you unless you contact us. Any personal data we do collect will only be used for internal administration purposes or to inform you of Society events or other Hispanic information that may be of interest to you..

Please make yourself aware of this Privacy Policy; your acceptance of Our Privacy Policy is deemed to occur upon your first use of Our Site. If you do not accept and agree with this Privacy Policy, you must stop using Our Site immediately.

2. Definitions and Interpretation

In this Policy, the following terms shall have the following meanings:

“personal data”	means any and all data that relates to an identifiable person who can be directly or indirectly identified from that data. In this case, it means personal data that you give to Us via Our Site or by other means. This definition shall, where applicable, incorporate the definitions provided in the UK General Data Protection Regulation (UK GDPR) and the Data Protection Act 2018.
“We/Us/Our”	means Portsmouth Hispanic Society.

3. Information About Us

- a. Our Site is operated by Portsmouth Hispanic Society,

4. What Does This Policy Cover?

This Privacy Policy applies only to your use of Our Site. Our Site may contain links to other websites. Please note that We have no control over how your data is collected, stored, or used by other websites and We advise you to check the privacy policies of any such websites before providing any data to them.

5. Your Rights

- a. As a data subject, you have the following rights under the GDPR,
 - i. The right to be informed about Our collection and use of personal data;
 - ii. The right of access to the personal data we hold about you (see section 10);

- iii. The right to rectification if any personal data We hold about you is inaccurate or incomplete (please contact Us using the details in section 10);
 - iv. The right to be forgotten – i.e. the right to ask Us to delete any personal data We hold about you (We only hold your personal data for as explained in section 7 but if you would like Us to delete it, please contact Us using the details in section 10);
 - v. The right to restrict (i.e. prevent) the processing of your personal data;
 - vi. The right to data portability (obtaining a copy of your personal data to re-use with another service or organisation);
 - vii. The right to object to Us using your personal data for particular purposes; and
 - viii. Rights with respect to automated decision making and profiling.
- b. If you have any cause for complaint about Our use of your personal data, please contact Us using the details provided in section 10 and We will do Our best to solve the problem for you. If We are unable to help, you also have the right to lodge a complaint with the UK’s supervisory authority, the Information Commissioner’s Office.
 - c. For further information about your rights, please contact the Information Commissioner’s Office or your local Citizens Advice Bureau.

6. What Data Do We Collect?

- a. We collect personal data to enable us to communicate with you and also to enable us to make our communications more relevant to you. We also use this data to enable the administration of Society events..
- b. We do not place cookies on your computer or device for any purpose relative to your personal data.
- c. If you send Us an email, we may collect your name, your email address, and any other information which you choose to give Us.

7. How Do We Use Your Data?

- a. If we do collect any personal data, it will be processed and stored securely, for no longer than is necessary in light of the reason(s) for which it was first collected. We will comply with Our obligations and safeguard your rights under the GDPR at all times. For more details on security see section 8 below.
- b. As noted above, We do not generally collect any personal data. If you contact Us and We obtain your personal details from your email, We may use them as follows:
 - i. To reply to your email.
 - ii. To provide you with information about the Society or Hispanic affairs we deem relevant to you or of interest to you.
- c. You have the right to withdraw your consent to us using your personal data at any time, and to request that we delete it.
- d. We will not share any of your data with any third parties for any purposes.

8. How and Where Do We Store Your Data?

1.1 We only keep your personal data for as long as We need to in order to use it as described above in sections 6 and 7 and/or for as long as We have your permission to keep it.

9. How Can You Access Your Data?

You have the right to ask for a copy of any of your personal data held by Us (where such data is held). Under the GDPR, no fee is payable and We will provide any and all information in response to your request free of charge.
